MEMBER ELIGIBILITY

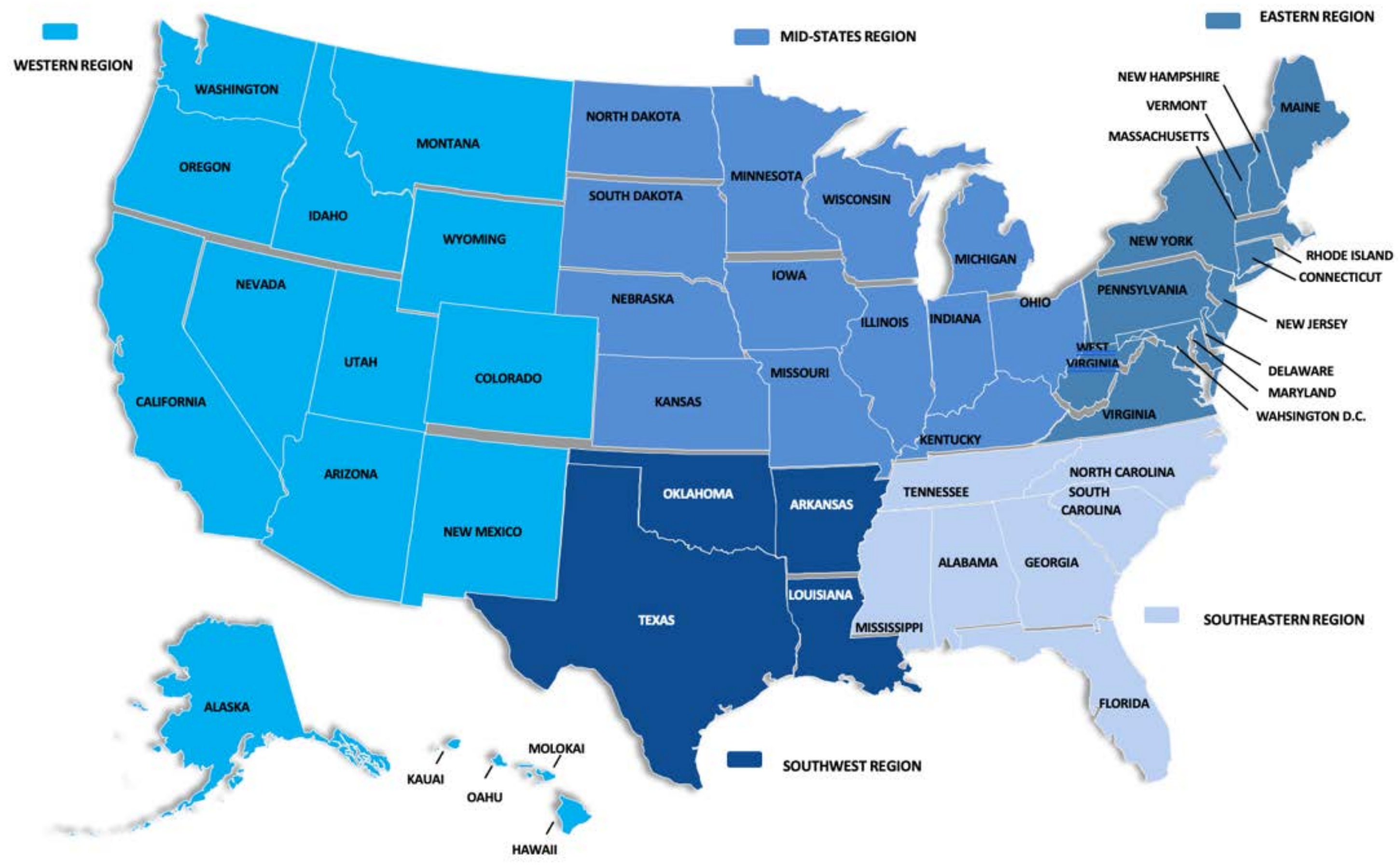
NAIIA member firms are asked to meet the following chief standards:

- The sole proprietor of a regular (full) member firm/or one of its partners corporate officers/ must have five years of adjusting skills and three years experience in an ownership and/or official capacity, maintaining proper licensing and E&O insurance.
- Sole proprietors/partners and corporate officers must be **ACTIVELY** involved in their adjusting operations.
- Or provisional membership, becoming eligible for regular membership when criteria has been met.
